EVALUATION INFORMATION

The Evaluation Panel will be using the below criteria to assess each application.

Applications must:

1. Relate to minimising gambling harm.
2. Support community and whānau.
3. Focuses on supporting a priority group (Māori, Pasifika and Asian populations; Rangatahi; Rainbow, Takatāpui and MVPFFAF+ populations; and Disabled Peoples)
4. Meet the tier one assessment

We're especially interested in work that:

1. Leads from te ao Māori, Pasifika or Asian world views
2. Is a community driven solution responding to a need in your community/whānau
3. Addresses minimising gambling harm in innovative ways

Once the tier one assessment is complete, the evaluation panel will assess the applications based on the **tier two assessment**. The tier two assessment is different for Pool A and Pool B. See both below.
